Women Lawyers of Alameda County (WLAC)

Judge Dickinson was appointed to a judgeship in the Alameda County Superior Court in November 2017 by Governor Jerry Brown. Prior to her appointment, she served as an Assistant Public Defender at the Alameda County Public Defender's Office from 2013 to 2017, and as Deputy Public Defender starting in 1989. During her 28-year tenure, Judge Dickinson served on the in-house training team conducting trainings on alternative dispute resolution for international attorneys and judges, as well as various evidentiary and criminal practice issues.

As President of WLAC, Judge Dickinson has overseen the creation of its new website designed to connect women in the legal profession with support, mentors, and information that strengthens careers. Additionally, she has worked extensively in the Juvenile Justice System, focusing most recently on a collaborative court system which treats mentally ill juvenile offenders. This touches a wide variety of communities and helps to address gaps in services for at-risk juveniles.

KEYNOTE SPEAKER

The Honorable Benjamin T. Reyes II



Appointed by Governor Jerry Brown in May 2017, Judge Benjamin T. Reyes II is the first Filipino American to serve as judge for Contra Costa County.

For most of his 24 years as an attorney, Judge Reyes managed a public agency practice. He was an Equity Principal at Meyers, Nave, Riback, Silver and Wilson since 2005, where he was an associate from 2001 to 2005. He served as General Counsel of Utility.com from 2000 to 2001 and as an attorney at the East Bay Municipal Utility District from 1997 to 2000.

Judge Reyes started his career in public law as a Deputy City Attorney at the San Jose City Attorney's Office in 1997. He was an associate at Boornazian, Jensen and Garthe from 1993 to 1997.

He was born in the Philippines and grew up in Honolulu and Alameda. He served in the U.S. Army Reserves from 1983 to 1987. He earned a B.A. degree from UC Berkeley and a Juris Doctor degree from University of San Francisco School of Law.

Judge Reyes is active in the Filipino Bar Association of Northern California and the Asian American Bar Association. He teaches on the faculty of the University of San Francisco School of Law Intensive Advocacy Program and volunteers as an instructor for the Trial Skills Program at Stanford Law School.

Commissioner Toni Mims-Cochran Alameda County Bar Association (ACBA)

Commissioner Mims-Cochran joined the bench in 2016. She started her legal career as a staff attorney for the Eviction Defense Center. She then ran her own solo practice for 14 years in Oakland, focusing on business litigation, family law, landlord/tenant litigation, and juvenile dependency trials and appeals. Commissioner Mims-Cochran is passionate about giving back. She is a past ACBA President and has been an active member of the legal community, serving as Co-Chair for the East Bay Diversity Bar Coalition, a member of the Charles Houston Bar Association, three term President of Women Lawyers of Alameda County, and Second Vice President of California Women Lawyers.

Palak B. Sheth

American Constitution Society, Bay Area Lawyer Chapter (ACS BALC)

Palak proudly serves San Francisco as the Managing Director of the Affirmative Litigation Task Force at the San Francisco City Attorney's Office, where she manages the team charged with bringing cases against companies violating consumer protection laws. Lois Prentice

Marin County Women Lawyers (MCWL)

Lois founded Marin County Women Lawyers (originally North Bay Women Lawyers) in 1976 when there were very few women in the law and blatant sexism was rampant. Lois has remained an active member of the Board advocating for diversity on the bench, and working on issues such as domestic abuse and rape in the military. She is the current Chair of MCWL's Program Committee.

As a trial lawyer with a practice in Sausalito, Lois has handled numerous noteworthy matters, including first-degree murder trials, representation of Judge Francis McCarthy, filing an amicus brief resulting in the Supreme Court reversing its own ruling, and the divorce of Grace Slick, representing her husband Jerry. Lois often takes cases for worthy causes without pay. In 1974, Lois married environmental lawyer Zeke Grader.

Hon. Barbara O'Hearn

Queen's Bench Bar Association

Judge O'Hearn has spent her career fighting for social justice and civil rights. She has been an attorney since 1980 and an Administrative Law Judge for the California Unemployment Insurance Appeals Board since 2007. She has devoted her practice to public interest and governmental law, working with the CA Department of Social Services, the Community Care Licensing Division, and as Deputy Director of the SF Rent Stabilization and Arbitration Board. Since 1987, Judge O'Hearn has served on the Queen's Bench Bar Association, Women Lawyers of Sacramento, Sacramento County Bar Association, and California Women Lawyers.

Judge O'Hearn has been a fierce advocate for the advancement of women and other minorities in the legal profession in general and in public service specifically. For the past 6 years, she has provided outstanding support to dozens of women lawyers as the Mentor Leader of the Queen's Bench Public and Government Law group. She is a true public servant and advocate for diversity in the legal field.

Christine Mari Palma Start
Filipino Bar Association of Northern California (FBANC)

Christine is a Deputy Public Defender with the Solano County Alternate Public Defender. She proudly represents indigent individuals charged with crimes from arraignment through jury trial and post-conviction. During her tenure as President of FBANC, Christine founded and led the country's first-ever Pinay Powerhouse Conference, an inaugural women's conference focused on the empowerment of Filipina attorneys and aspiring attorneys as leaders in law.

Christine serves as FBANC Advisory Board member, National Filipino American Lawyers Association's Women Lawyers Network Co-Chair, MBC Co-Chair, USF Public Interest Law Foundation Advisory Board member, and Racial Justice Committee member at her place of employment. She is a certified professional life coach and a devoted yoga and social justice practitioner. Christine is a recipient of the Pursuit of Justice Award of her law school graduating class. In 2015, she was recognized with the Solano County Public Defender's Thurgood Marshall "Intricate Planner and Defender of the Poor" Award. In 2017, she was awarded the prestigious "Best Lawyers Under 40" Award by the National Asian Pacific American Bar Association.

Elica Vafaie
Iranian American Bar Association (IABA)

Elica is staff attorney and program manager of the National Security and Civil Rights program at Asian Americans Advancing Justice – Asian Law Caucus. Elica previously helped establish the UC Undocumented Legal Services Center providing free immigration legal services and know your rights training to mixed status UC students and their families across California as the supervising attorney. She was the Project Director of the One Nation Initiative at the California Community Foundation (CCF) in Los Angeles where she managed the first philanthropic program in Southern California to support Arab, Middle Eastern, Muslim, and South Asian community civic engagement, policy advocacy, as well as nonprofit capacity building. He founded and was the first Director of USF's Center for Applied Legal Ethics. He was coordinator of USF's ethics curriculum and also taught Trial Practice. Richard has also chaired the California State Bar's ethics committee; been awarded the ABA's Pro Bono Publico Award in 2006; continually remained in private practice, trying 50 cases to verdict; become a CA certified specialist in legal malpractice law in 2010; and been technical advisor to the film Class Action.

Richard has long been dedicated to making sure the legal community is diverse. He has championed BASF JDC's Bay Area Minority Law Student Scholarship program for decades, as a donor, a member of the awards committee, and a mentor to people of color in law school and beyond.

Jennifer Orthwein
Bay Area Lawyers for Individual Freedom (BALIF)

Jennifer transitioned from a career as a forensic psychologist to focus on legal and policy issues related to transgender and gender variant individuals, particularly those impacted by the criminal justice system. She helped launch and served as pro bono Senior Counsel for the Detention Project at Transgender Law Center. She assisted in the representation of two California prisoners, Michelle-Lael Norsworthy and Shiloh Quine. These cases were the impetus for access to gender affirming surgery and expression for transgender and gender variant people in California prisons.

Jennifer previously maintained a successful legal and psychological consulting practice providing expert witness services to attorneys. Her work focused on assisting attorneys representing transgender people involved in civil and criminal cases. Jennifer has co-authored publications related to practitioner liability in cases of suicide as well as gender bias in the California criminal justice system. She is also a co-principal investigator for the Transgender Research Consortium which aims to provide empirical evidence on the impact of discrimination on transgender people's physical and mental health and to use this data to provide recommendations to inform public policy, education, training, and clinical practice.

Megan M. Lawson
Black Women Lawyers of Northern California (BWLNC)

Megan is an employment law attorney in Orrick's Silicon Valley Office. She defends companies in class action, multi-plaintiff and single plaintiff lawsuits under California and federal law on a variety of issues, including discrimination, harassment, wrongful termination claims and wage-and-hour matters. Most notably, Megan served on the trial team that resulted in the firm's resounding victory for venture capital firm Kleiner, Perkins, Caufield & Byers in the highly publicized gender discrimination lawsuit brought by Ellen Pao.

Megan also provides employment counseling to companies on a variety of employment issues and legislation. She has served on the Black Women Lawyers of Northern California Board in various capacities and gives back to her community through pro bono work.

Shanae Buffington
California Association of Black Lawyers (CABL)

Shanae is an attorney at the California Employment Development Department in Sacramento. Prior to that, she worked for the Yolo County Public Defender's Office and Randolph, Cregger & Chalfant. Shanae serves as the Treasurer of the California Association of Black Lawyers and Secretary/Treasurer of the Sacramento County Bar Association (SCBA). She is also a past president of the Wiley W. Manuel Bar Association.

Shanae is the current Program Chair of SCBA's Kids Law Day, a program that provides an interactive experience to expose children in grades four through six to careers in the legal profession. Shanae's passion for diversifying the legal profession is evident through her work with CABL and SCBA.

Deborah Moss-West
Charles Houston Bar Association (CHBA)

Deborah serves as the Executive Director of the Katharine & George Alexander Community Law Center at Santa Clara University School of Law. Prior to that, she served as their Director of the Center for Social Justice and Public Service. During her tenure at the Center she expanded the law school's pro bono programs, launched the Marshall-Brennan initiative and other pipeline programs, pioneered an undergraduate law and social justice class and pathway, and has been integral to building the Center and its reputation in the lawyering community.
